- 2) *Politicizing Domesticity from Henrietta Maria to Milton's Eve*. Cambridge: Cambridge University Press, 2011. xiv + 225 pp.

Bringing together literary texts, political and household writings, and visual images, this book traces how the language of the domestic became a powerful and contested tool of political propaganda in representations of Charles I and Henrietta Maria, Oliver and Elizabeth Cromwell, and Milton's Adam and Eve. Challenging previous binaries of public and private, political and domestic, the book demonstrates that the domestication of the royal family image is an important and largely unrecognized legacy of the English Revolution. The study will appeal to scholars of political and cultural history, literature, book history and women's studies.

This Companion introduces advanced undergraduates, graduate students, and faculty to the range, complexity, historical importance, and aesthetic merit of women's writing in Britain, 1500-1700. A comprehensive Introduction and nineteen new analytical essays offer the most up-to-date scholarship and set out current issues and debates, while providing the tools to enable students to read early women's texts with new understanding and enjoyment. This volume is innovative in its attention to the materiality of writing, to the spaces in which women typically wrote, and to the varied genres or modes of women's writing.

4) *The 1671 poems, Paradise Regain'd and Samson Agonistes, Volume 2, The Complete Works of John Milton*, gen. ed. Thomas Corns and Gordon Campbell. Oxford: Oxford University Press, 2008. 284 pp. Winner of the Milton Society of America's John T. Shawcross Award for a distinguished edition of Milton's works.

Bringing together literary criticism, historical bibliography, and religious, political, and print history, this volume offers a definitive scholarly edition of John Milton's *Paradise Regain'd* and *Samson Agonistes*. The edited text is based on extensive collation of the 1671 and 1680 volumes. Drawing on new archival sources and up-to-date historiography, a detailed Introduction sets out the cultural, religious, and political contexts of 1670-71. A discussion of Milton's bold transformation of classical epic and tragedy provides literary historical context. This edition also breaks new ground by including materials on early owners and readers. Textual Commentary provides precise OED word definitions, identifies biblical, classical, historical, and geographical references, and explains Latin, Greek, and Hebrew usages.
