ENGL 40327: The Victorian Universe, Fall 2011, Fall 2012, Fall 2014, Fall 2020

Elective for majors focusing on the form of the Victorian multi-plot novel, and its contexts in Victorian thought on gender, science, and economics.

Independent Study: Sam Evola, Spring 2014

Guided course of reading designed to acquaint a graduating senior with nineteenth-century British literature. No other nineteenth-century British literature course was being offered this semester, and the student had expressed a strong interest in possibly pursuing graduate study in English.

Required gateway course to the English major focusing the basic questions involved in the study of fiction, poetry, drama, and literary theory, and the procedures that scholars use to answer those questions.

ENGL 465R Victorian Radicals, Fall 2004, Spring 2005

Senior research seminar exploring the Pre-Raphaelite, Arts and Crafts, and Decadent movements of the nineteenth century, with assignments designed to lead up to an original, seminar-length research paper.

ENGL 411 British Literary Traditions II, Spring 2005

Survey of British literature from 1666 to 2005, with a special emphasis on the diasporic and Celtic influences on the British literary tradition.

ENGL 463M: Natives and Novels, Spring 2004

Methods course designed to give majors a sense of how literary scholars talk about the form of the novel and its relationship to national and international contexts in which it evolved.

ENGL 464: Victorian National Romance, Fall 2003, Fall 2004, Spring 2006, Fall 2007

Course for majors exploring literary form, gender, and ideas of national affiliation in nineteenth-century literature.
